

**Campbell's Scottish Highlands is committed to the safety of our staff and guests.**

*While the State of NH has ended the Mask Mandate and Industry Specific Guidelines, we at Scottish Highlands plan to follow the State of NH and CDC recommendations to keep our staff and guests safe and prevent the spread of COVID-19.* We truly hope that in addition to being effective, these practices make you feel more at ease and able to enjoy your visit to the course. Please follow all CDC COVID-19 recommendations while on the premises including mask wearing for unvaccinated individuals, social distancing, frequent handwashing and sanitizing.

- **For Fully Vaccinated Customers** - Masks are Optional in the Clubhouse, Bar & Grill and Driving Range Buildings.
- Unvaccinated Customers **SHOULD** Wear a Mask **at all times** when in the **Clubhouse, Bar & Grill** (**unless** you are **seated** at a dining table) and in the **Driving Range Building**.
- We have our tables and chairs arranged to provide the maximum number of seats allowed while following social distancing. **PLEASE DO NOT MOVE TABLES & CHAIRS** on the Patio or in the Bar & Grill.
- **The Bar & Grill Hours of Operation** may be modified. *Please see the "Hours" Page of our web site for specific hours of operation.* **scottishhighlandsgolf.com**
- **The Beverage Cart** (Hours are Weather Dependent and Will Vary).
- Golfers are welcome to bring their own **non-alcoholic beverages** and **food items** for consumption on the Golf Course (not on the patio or in the clubhouse.)
- **The Driving Range - Hours of Operation** are back to normal. *Please see the "Hours" Page of our web site for specific hours of operation.* **scottishhighlandsgolf.com** Range Telephone: 603-896-6500
- Although the **Clubhouse Lobby, Proshop, Restrooms & Range Building** will be open, **access will be restricted by social distancing guidelines.** *Unvaccinated Customers should wear a mask (over the mouth and nose) when entering the buildings and should remain masked while in the buildings (unless seated at a table eating or drinking.) Everyone should remain at least 6 feet apart. You may be asked to "wait your turn" at designated spots or outside to allow space for social distancing.*
- There will be **No "Ice & Water Machine" Use** in the Clubhouse.
- **Carts can be shared by two golfers.** Walking is encouraged; however, double occupancy of carts is allowed. We will only allow individual cart use based on availability. **This will be determined at the club's discretion based on the amount of tee times reserved for the day.**
- We will **clean the carts** often. Please return your cart promptly at the end of your round to allow time for cleaning. **Twilight Golfers** - Please be courteous and return your carts by the "Cart Turn in Time" that is posted in the Pro-shop to allow for cleaning the carts before dark.
- **Leaving the Flag Sticks in the holes is encouraged.**
- We strongly urge our visitors to take personal care. **Utilize personal distancing, do not handle other players clubs or golf balls.** Tap clubs or shoes at the end of the round rather than the customary hand shake. **Wash hands frequently, use sanitizer often.** We are trying our best to provide hand sanitizer but may not have any at times so visitors may have to bring their own.
- The **Business Office** will be open but due to the small layout, which inhibits the ability to social distance, unvaccinated customers should wear a mask while in the Business Office.
